The Story of Ray and Gilby

Ray is a retired Montreal Police Officer in his mid 70's. There are hundreds of Knights of Columbus members in the Montreal Police Department, and so throughout his career, he was often asked by his colleagues to join the Order. Ray always resisted, insisting that he's not a "joiner". He was active singing in the Montreal Police Choir and that was enough. Ray retired quite young and he and his wife Gilby, enjoyed travelling to Europe every couple of years, and visiting with family members all over Quebec. Life was good!

Around the time that Long Term Care Insurance became available, his son-in-law, who is a Knight, encouraged him to join the Knights of Columbus and therefore become eligible to gain access to Long Term Care Insurance. His son-in-law explained that the Long Term Care Insurance is an "asset protector". If either he or Gilby require extended care in their later years, the Long Term Care Insurance would cover it and his retirement funds would be unaffected. Again, Ray resisted.

A couple of years went by and eventually their daughter, Annie, noticed that her mother, Gilby was becoming forgetful and generally not as mentally sharp as she had been. Annie encouraged her parents to have her Mother assessed. A short time later, it was discovered that she was in the initial stages of Alzheimer's. This certainly got Ray's attention, and so he asked his son-in-law about the Long Term Care coverage that the Knights of Columbus offered its members. In fact, he decided that he would join the Knights of Columbus to get access to it. His son-in-law explained that it would be too late now because Gilby's illness would be a pre-existing condition, therefore making her ineligible.

Gilby's condition worsened very quickly and soon Ray started to see the financial implications of Gilby's illness. He served as her care-giver for as long as he could but it took its toll. His daughter, Annie said he was "aging by the day". Eventually, Ray sold his home and scaled down to a condo, which was a good move because the house was too big for just the two of them anyway. When it became too much for Ray, he had no other choice but to place Gilby in a Nursing Home.

Ray always worried about money, and he was shocked to learn that the monthly cost of Gilby's care was \$2,650/month. Paying over \$30,000/year for Gilby's care is a worrisome proposition. Gilby was 78 when she was placed in a Nursing Home and in her large family of 12 siblings living into their 90's is common. Ray could be paying for Gilby's care for many years. He's facing a financial crisis.

If Ray had joined the Knights of Columbus when he was asked those numerous times, he could have gotten Long Term Care Insurance. The cost of Gilby's care, \$2,650/month, under a Long Term Care contract would have cost Ray only \$207/month. So, by not acting on his son-in-law's advice, he's paying over ten times more than he needed to. That's why Long Term Care insurance is seen as an "asset protector".

I know this situation very well. You see, I'm the son-in-law who encouraged Ray to join the Knights of Columbus. Their daughter, Annie, is my wife. We've been in the middle of a situation that could have been avoided. So, I tell this story to encourage members to be more proactive than Ray was.

As members of the Knights of Columbus, you can avoid the financial and emotional turmoil that is all too common with this type of situation.

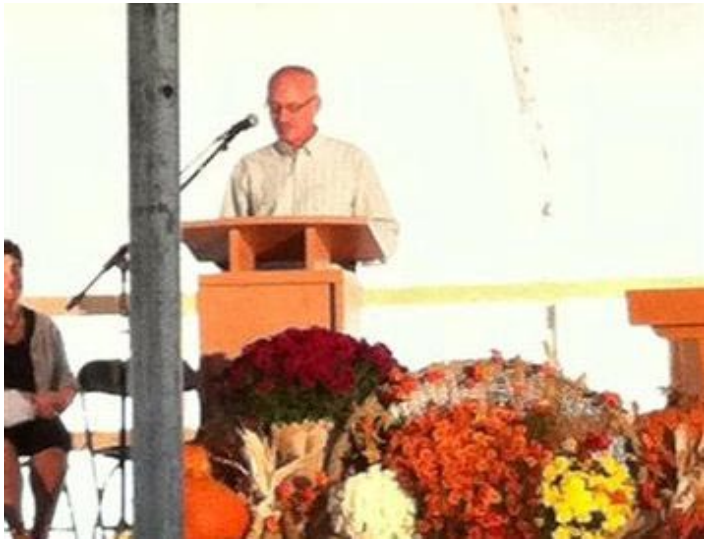
Larry Judge and Alain Langlois proudly carry the colours with the Legion Colour Party.
